ORDER

- 1. No application for suppression has been made in this case and no suppression orders apply around publication of this decision.
- 2. The tenancy of Soo Toleafoa at 16 Thalia Place, Totara Vale, Auckland 0629 is terminated, and possession is granted to Ambika Nand and Arun Nand, at 5:00pm on Wednesday 9th June 2021.
- 3. The Bond Centre is to pay the bond of \$2,600.00 (3406467-009) to Ambika Nand and Arun Nand immediately.
- 4. Soo Toleafoa must pay Ambika Nand and Arun Nand \$7,170.44 immediately, calculated as shown in the table below:

Reasons:

1. The landlord attended the hearing. The tenant did not.

- 2. The landlord has applied for termination of the tenancy, rent arrears and refund of the bond.
- 3. Rent was at least 21 days in arrears on the date the application was filed. The tenancy is terminated. See section 55(1)(a) Residential Tenancies Act 1986.
- 4. The landlord provided rent records which prove the amount owing at the end of the tenancy. Rent owing to 9th June 2021 is \$9,750.00.
- 5. I award the amount accordingly.

Filing fee reimbursement

6. Because the landlord has wholly succeeded with the claim, the tenant must reimburse the filing fee.

Rehearings

You can apply for a rehearing if you believe that a substantial wrong or miscarriage of justice has happened. For example:

- you did not get the letter telling you the date of the hearing, or
- the adjudicator improperly admitted or rejected evidence, or
- new evidence, relating to the original application, has become available.

You must give reasons and evidence to support your application for a rehearing. A rehearing will not be granted just because you disagree with the decision. You must apply within five working days of the decision using the Application for Rehearing form: justice.govt.nz/assets/Documents/Forms/TT-Application-for-rehearing.pdf

Right of Appeal

Both the landlord and the tenant can file an appeal. You should file your appeal at the District Court where the original hearing took place. The cost for an appeal is \$200. You must apply within 10 working days after the decision is issued using this Appeal to the District Court form: justice.govt.nz/tribunals/tenancy/rehearings-appeals

Grounds for an appeal

You can appeal if you think the decision was wrong, but not because you don't like the decision. For some cases, there'll be no right to appeal. For example, you can't appeal:

- against an interim order
- a final order for the payment of less than \$1000
- a final order to undertake work worth less than \$1000.

Enforcement

Where the Tribunal made an order about money or property this is called a **civil debt**. The Ministry of Justice Collections Team can assist with enforcing civil debt. You can contact the collections team on 0800 233 222 or go to justice.govt.nz/fines/civil-debt for forms and information.

Notice to a party ordered to pay money or vacate premises, etc.

Failure to comply with any order may result in substantial additional costs for enforcement. It may also involve being ordered to appear in the District Court for an examination of your means or seizure of your property.
