MEMORANDUM-DIRECTIONS OF THE PRESIDING OFFICER

1 October 2018

1. Tribunal staff have completed a preliminary eligibility assessment of the historical aspects of claims before the Tribunal that fall within the scope of this inquiry. As noted in my previous memorandum-directions of 6 September 2018 (Wai 2800, #2.5.1), the standing panel will consider claims in the following inquiry districts:
 - (a) Taranaki;
 - (b) Whanganui;
 - (c) Te Whanganui a Tara/Wellington;
 - (d) Te Tau Ihu/Northern South Island;
 - (e) South Island; and
 - (f) Rekohu/Wharekauri/Chatham Islands.
2. I note that in undertaking this assessment, Tribunal staff have considered only the historical allegations contained in the claims. It is likely that many of the claims assessed as being fully settled still contain contemporary allegations that remain in the Tribunal's jurisdiction. Claims containing only contemporary allegations, however, are outside the scope of the present inquiry.
3. The list of claims that have been assessed as possibly eligible to participate in this inquiry are listed in **Appendix A**. A number of the claims on this list do not contain sufficient information to determine whether or not the historical aspects remain within the Tribunal's jurisdiction. Most claims will require further particularisation before they can be inquired into. It may be that in the process of particularisation it becomes apparent that some of these claims are in fact beyond the scope of the Tribunal's jurisdiction or beyond the scope of this inquiry. The list in Appendix A is therefore a preliminary indication only.
4. Attached as **Appendix B** is a preliminary list of claims that staff have determined as not eligible to participate in this inquiry. The reason the historical aspects of each claim have been assessed as ineligible is noted briefly alongside the claim. These reasons include that the historical aspects of the claim:
 - (a) have been settled by legislation and removed from the Tribunal's jurisdiction;
 - (b) are included in current settlement negotiations;
 - (c) are participating in current Tribunal inquiries; or
 - (d) have already been reported on by the Tribunal.
5. If any parties consider the assessment of their claim to be incorrect, they are to file submissions explaining how their claim comes within the scope of this inquiry by no later than **midday, Friday 28 December 2018**.

The Registrar is to send this direction to all those on the notification list for Wai 2800, the Inquiry into Remaining Historical Claims: Southern North Island and South Island Claims.
