E TE RŌPŪ WHAKAMANA I TE TIRITI:

1. He manatu tēnei nā mātou ngā rōia o te kaikerēme o Wai 1718, arā, o Dr Cathy Moana Dewes. He mea tuku te kerēme Wai 1718 nei e Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa (**Te Rūnanga Nui**) me ngā whānau whānui o ngā Kura Kaupapa Māori Te Aho Matua (ngā **Kaikerēme**).

*This memorandum of counsel is filed on behalf of the named claimant for Wai 1718, Dr Cathy Moana Dewes. The Wai 1718 claim is made on behalf of Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa (**Te Rūnanga Nui**) and all whānau of Kura Kaupapa Māori Te Aho Matua (the **Claimants**).*
