TEENAA, E TE ROOPUU WHAKAMANA I TE TIRITI O WAITANGI:

1. This Memorandum of Counsel is filed in relation to the priority inquiry into the disestablishment of Te Aka Whai Ora (“Priority Inquiry”), on behalf of the following claimants (“the claimants”):
 - (a) Ngaati Hine (Wai 682);
 - (b) Te Kapotai (Wai 1464/1546); and
 - (c) Te Ruunanga Nui o Te Aupoouri Trust (Wai 2831).
2. On 1 October 2024, His Honour Judge Stone directed that claimant and interested party closing submissions in the Priority Inquiry should be filed by 5pm, Monday 14 October 2024.¹
3. Counsel had initially suggested the 14 October 2024 as a filing date for closing submissions, however this did not anticipate the Wai 3300 Treaty Principles Bill urgent inquiry taking place within the same timeframe. As counsel have been working towards competing deadlines, we are unable to meet the 14 October 2024 deadline.
4. Counsel respectfully seek an extension until 5pm, Tuesday 15 October 2024 to file closing submissions.
