TĒNĀ E TE RŌPŪ WHAKAMANA I TE TIRITI O WAITANGI

1. This Memorandum of Counsel is filed on behalf of Wai 3080, a claim by Hemi Te Peeti, Karla Puhipuhi, Ani Skipper, Miriama Ketu, Nina Pilkington, Tawhiti Kunaiti and Lani Ketu for and on behalf of Ngati Whakaterere ki te Tonga (“the Claimants”).
2. In her Memorandum-Directions dated 25 September 2025,¹ Kaiwhakawā Wainwright directed counsel to file memoranda by 5:00 pm on 8 October 2025 addressing the following matters:
 - a) The identification of kaikōrero who are yet to be heard as part of He Rau Kōrero ā Tara Whare, together with accompanying details;
 - b) Kaikōrero currently in custody, with accompanying details; and
 - c) Recommendations as to which sites, programmes, processes, and courts should be prioritised for panel visits.
3. Counsel are continuing to confirm instructions with claimants regarding kaikōrero who are yet to be heard in, ‘He Rau Kōrero ā Tara Whare.’ Given the importance of ensuring that all claimant voices are properly represented and that participation in this kaupapa is facilitated in a fair and orderly manner, counsel respectfully seek an extension until Thursday, 16 October 2025, to complete this process.
4. Counsel submit that granting this extension will promote procedural fairness and efficiency, and that little, if any, prejudice will result from the time sought.
