
1. Kua whakakōnaetia tēnei manatu rōia mō ngā kerēme e whai ake nei:

1. This memorandum of counsel is filed on behalf of the following claims:
  - (a) Wai 1341, a claim by Noral Rameka on behalf of Te Rūnanga o Ngāti Rēhia for the hapū of Ngāti Rēhia; and
  - (b) Wai 1359, a claim by the late Sir Graham Latimer and Tina Patricia Latimer on behalf of themselves and the descendants of Paora (Te Paatu), Paerata (Te Paatu Koraha), Hare Reweti Hukatere (Te Paatu Tere Tere), Ratima Aperahama (Whakakohatu, Tokaawai, Te Uriaranui) and Marara Ratima (Te Paatu me Ngaitohianga)
