claim my son and I are prejudicially effected by Housing N.Z. Policies  
now and in the future 1. Housing N.Z. Restructuring Bill now before  
Parliament Ballot - Labour Party Paul Swain Housing Spokesman.  
and I claim that these matters are contrary to the principles of the  
Treaty of Waitangi therefore I seek the following relief.

1) to ensure Crown land stays under ownership of the  
Tribe so that Whanau can have a rental or own Housing N.Z  
Homes, built into future Housing Papakainga Structures  
as there is no Social Policy at present in relation to Housing  
N.Z. formerly State Advance Corporation. for redress.

I wish the Tribunal to Commission a research done in  
1954 Tamaki Makauau by Dame Whina Cooper. (Archives in W  
who provided my Mother Hera nee Maioha now deceased W. League.  
Houses based on her needs at the time in 1954 as the move from  
rural to urban effected us all my Whanau and now my present  
Health. therefore I wish to be heard Orally I choose Te Unga Wake  
Marae 33 Margot St. Epsom to be the Venue and I will expect a
