

**May it Please the Tribunal**

1. I, David Te Hurihanganui Whata Wickliffe, Maori land owner and or Trustee of the geothermally active Maori land blocks attached marked Schedule 1, wish to have each of these blocks joined as co-claimant to the Te Arawa Geothermal Cluster that supports the position of New Zealand Maori Council and Sir Graham Latimer claiming ownership interests in the freshwater and geothermal resources.
2. The land blocks are all Maori land trusts or incorporations established under the auspices of Te Ture Whenua Maori Land Act 1993.
3. In 1993, these Maori land blocks all supported their claims being prosecuted under the one collective umbrella Te Arawa Representative Geothermal Resource Claims. A preliminary report was provided by the Waitangi Tribunal in late 1993 however that Report did not address claims to ownership of the geothermal resources, as the Governments policy focus was on management issues and management regimes.
4. I seek the opportunity for each of these blocks to be able to describe their associations to the customary geothermal fields of Te Arawa and to assert ownership rights and management rights in the geothermal resource.
