

**STAGE II HEARINGS
PLANNING FOR
TE PAPARAHI O TE RAKI WAI 1040**

IF WE BEGIN THE STAGE II HEARINGS WITH 21 WEEKS

WEEK 1 WILL INCLUDE POWHIRI AND SITE VISITS

POWHIRI – THE TRIBUNAL AND OTHERS WILL LAND ON THE JETTY OUTSIDE OF THE COPTHORNE HOTEL IN WAITANGI BY WAY OF SEA GOING VESSEL. THEY WILL PROCEED THROUGH THE COPTHORNE COMPLEX TO THE BRIDGE. CONCLUSION OF THE POWHIRI WILL BE AT THE TAU RANGATIRA WHERE THE MIHIMIHI WILL BE HELD.

SITE VISIT – ROHE MOANA - THIS WILL BEGIN BACK AT THE COPTHORNE JETTY ON A SEA GOING VESSEL, WHICH WILL MAKE SALE FROM WAITANGI/BAY OF ISLANDS THEN NORTH TO THE WHANGAROA HARBOUR. THIS WILL ALLOW SITES OF SIGNIFICANCE TO BE IDENTIFIED WITHIN THE ROHE MOANA OF TE PAPARAHI O TE RAKI WAI 1040.

SITE VISIT – BEGINNING IN WHANGAROA, POSSIBLE JOURNEY TO WEST COAST, SOUTH DOWN THE WEST COAST, ACROSS BACK TO EAST COAST, CONCLUDING BACK AT WAITANGI. THIS JOURNEY WILL TAKE APPROXIMATELY 4 DAYS TO COMPLETE AND WILL BE CONDUCTED ON THE MAIN ROUTE/ STATE HIGHWAYS.

WEEK 2 -21 - COMBINED GENERIC AND LOCAL HEARINGS

IF THERE ARE CONSISTANTLY 5 REGIONS IN TE PAPARAHI O TE RAKI WAI 1040, THIS WOULD GIVE AN EVEN 4 WEEKS PER REGION HEARING TIME. WE RECCOMEND THAT THE FIRST 2 DAYS OF EACH WEEK BE COMMITTED TO GENERIC HEARINGS AND THE CONCLUDING 3 DAYS BE COMMITTED TO LOCAL HEARINGS.

BREAKDOWN OF HEARING TIMETABLE

PER WEEK HEARING TIME:
